

Thanks to Gladys Buchanan (Diane Chema's mom) for taking time out of her summer to knit for the cause.







Dear Members of the Legal Profession and Concerned Citizens:

I am delighted to announce the launching of the Flint Youth Initiative ("FYI") – an innovative project designed to keep young people in Flint on the right side of the law.

Conceived by the U.S. District Court and the U.S. Attorney's Office for the Eastern District of Michigan, the initiative will reach out to students at the elementary school level, with the goal of inculcating the values of good citizenship, personal safety and productive lifestyles. By reaching children at a critically formative stage, we hope to save as many as possible from the fate of many Flint children -- a life devalued and degraded by drugs and violence. Those of us involved in the court system see the tragic outcomes far too often. Here is our chance to prevent some of those tragedies.

FYI will consist of two components. A "Lunch Buddy" program will pair up one adult with an individual student for a half-hour lunch period, once a week for one semester. Studies show such intensive, one-on-one encounters offer the best hope of creating a positive and long-lasting impact on a young person. A second component will be presentations to larger groups of students on citizenship, the law and personal safety, at various times during the school year. While we hope eventually to see FYI in place at a number of Flint schools, we will start with a pilot program at the Doyle/Ryder Elementary School, located at University Avenue and Saginaw Street in downtown Flint.

We will be holding an initial informational meeting for those interested in participating in either component of FYI. This one-hour meeting (with coffee and donuts provided) will take place on Friday, September 13, 2013 at 9 a.m. at our Flint courthouse. If you can join us, please RSVP to my case manager, Deborah Goltz, deborah_goltz@mied.uscourts.gov. If you cannot make the meeting, but are interested in participating, please let her know that as well. If you know of others involved in the legal profession or the administration of justice – or other suitable candidates -- who might be interested in participating, please share this letter with them.

I firmly believe FYI can have far-reaching consequences for the betterment of our community. As an ancient legal maxim teaches, "If you save a single life, you save an entire world." Your involvement will make a world of difference.
