

In honor of **Pro Bono Month**, the GCBA and the Legal Aid Committee plan to hold a Clean Slate Clinic on **October 30th**. Other Bar Associations and the Flint Police Department have done successful variations of this concept in the past.

For the 2015 Clean Slate Clinic, we envision morning and afternoon sessions where clients could have a short appointment with volunteer attorneys. Attorneys would assist walk-in clients by providing a packet of information and advice regarding how to qualify and apply for an expungement. For prescreened clients, attorneys would assist with the completion of the expungement application and other paperwork.

The clinic will take place at the Flint Farmers' Market at 300 East 1st Street, Flint, MI 48502. Legal Services of Eastern Michigan will provide assistance by prescreening clients who schedule an appointment ahead of time.

LSEM staff and GCBA volunteers could hold 20-30 minute client advice appointments in a 2 hour session running from 10 a.m. to 12 p.m. or 12 p.m. to 2 p.m. on October 30, 2015. GCBA volunteers could participate in either, or both, the morning or afternoon session.

RESPONSE OF ATTORNEY TOM R. PABST TO MICHIGAN COURT OF APPEALS DECISION REVERSING JURY VERDICT

A Michigan Court of Appeals' (hereinafter "MCOA") decision recently took a fairly won jury verdict in Judge Fullerton's Court away from Beverly Knox-Pipes, in a case tried by local attorney, Tom R. Pabst. The MCOA decision used the following four methods to justify taking away the jury's verdict.

FIRST – THE MCOA DECISION JUDICIALLY LEGISLATED AND ADDED TO THE EXISTING WHISTLEBLOWER LAW, THEN APPLIED ITS NEWLY EDITED LAW RETROACTIVELY TO TAKE AWAY THE JURY VERDICT, SPECIFICALLY DISREGARDING THE MICHIGAN SUPREME COURT'S RULING AND ADMONITION THAT THIS METHOD IS FORBIDDEN AND PROHIBITED TO BY USED BY MCOA JUDGES

The Michigan Court of Appeals' Opinion re-wrote the Whistleblower law to essentially require that "participating in a protected proceeding does not count if the plaintiff is a subject of the investigation", then applied the newly judicially rewritten law retroactively to take a fairly won jury verdict away from Plaintiff Beverly Knox-Pipes, and at the same time, it repudiated, contradicted, and *sub silentio* reversed the Michigan Supreme Court ruling in *Whitman v City of Burton*, 493 Mich 303 (2013) which expressly condemned this process of judicial legislation and forbade the Court of Appeals judges from engaging in it – which ruling was made explicit and clear two years ago in a published Opinion by our Supreme Court!

SECOND – THE MCOA DECISION JUDICIALLY EDITED/RE-WROTE THE MICHIGAN SUPREME COURT'S MICHIGAN RULE OF EVIDENCE 408 ENACTED IN 1978

The MCOA decision also essentially re-wrote the clear and unambiguous text of the Michigan Supreme Court's 1978 MRE 408 to eviscerate the last two sentences thereof, making a totally new Michigan Rule of Evidence 408, when the trial court and Plaintiff relied upon the complete 1978 MRE 408 as the evidential law of Michigan. The way the MCOA decision edited and re-wrote the 1978 MRE 408, it prevented any evidence showing Defendant Lisa Hagel's bias, prejudice, or basis for impeachment, when the last two sentences of that rule written by our Supreme Court specifically allow for that type of evidence to be used at trial.

THIRD - THE MCOA DECISION JUDICIALLY RE-WROTE PLAINTIFF'S PLEADINGS TO ACCOMPLISH THE RESULT THEY ENDED UP WITH

Not content with judicially re-writing the Whistleblower law, and our Supreme Court's MRE 408, the Michigan Court of Appeals Panel next judicially re-wrote Plaintiff's pleadings and pretended that Plaintiff did not plead "participation in a school investigation" when ¶43 of Plaintiff's Second Amended Complaint clearly pled that protected activity of participating in a School investigation – at least if you read the complete version of ¶43. Surprisingly, the MCOA decision only quoted part of our ¶43, but omitted the other part which negated and contradicted the very ruling that the MCOA decision just made! How the MCOA judges could have not seen the other part of our ¶43 that they themselves partially quoted is astounding.

FOURTH – IT'S OKAY WHEN DEFENDANT LISA HAGEL SAYS AND ADMITS THAT "NO CRIMINAL FAULT" WAS FOUND, BUT "MISCONDUCT" AND REVERSIBLE ERROR WHEN THE EXACT SAME PHRASE IS REPEATED BY ATTORNEY TOM R. PABST, WHO WAS QUOTING FROM A DOCUMENT THAT HAD BEEN ADMITTED INTO EVIDENCE WITHOUT OBJECTION!!

The MCOA actually ruled that it was improper and forbidden for Attorney Pabst to comment on, or mention, evidence properly admitted during trial of a press release issued by Defendant Hagel admitting that the prosecuting attorney found no criminal fault. In other words, Defendant Hagel could proclaim to all of the people in Genesee County and to the jury sworn to try this case that there was a finding of "failure to find criminal fault", but when Tom R. Pabst repeats the very same thing, it constitutes "serious misconduct" warranting reversal of a jury's verdict! This changes the rules of litigation that have been in existence since the time of President Abraham Lincoln, namely that it is proper for an attorney to comment on, and, in fact, argue documents that have been admitted into evidence such as this Press Release from Defendant Lisa Hagel:

"GISD RESPONSE TO LAPEER PROSECUTOR'S NOT PURSUING CRIMINAL CHARGES

For Immediate Release

* * *

"I would like to express my concern and displeasure over the failure to find criminal fault..."

This is a verbatim excerpt taken from Plaintiff's Trial Exhibit 22, which was introduced at trial for the jury's consideration without any objection from Defendant Lisa Hagel or her attorney.

CONCLUSION

With the above facts, you are in a position to decide for yourselves the justice and fairness of the legal process involved here. To those of my friends who wonder if it is proper to comment on a "pending legal matter", I cite to you the ruling of our own Michigan Supreme Court, and the words of one of its most prominent Justices, Cliff Taylor, who said that it is not only the "right" of an attorney to comment on judicial process, but the duty of an attorney to comment:

"While it is a lawyer's <u>duty</u>, when necessary, to challenge the rectitude of official action, it is also the lawyer's duty to uphold legal process."

See 476 Mich 231, p. 6 of 72.

I intend to apply for leave to our Michigan Supreme Court to prove two things:

- (1) That the MSC really meant it two years ago in its *Whitman, supra*, decision that this judicial legislation methodology is forbidden and prohibited; and
- (2) That neither Judge Fullerton nor I made any mistakes constituting in trying this case to jury verdict.
